SL-22: MCPHERSON CITY STREET LIGHTS

Availability:

Available within the city limits of McPherson, Kansas in accordance with the McPherson BPU's Terms and Conditions or Billing Practices for providing electric service.

Application:

For electric service supplied to municipal street lights for dusk to dawn lighting along public thorough-fares.

Character of Service:

Alternating current, approximately sixty (60) cycles, and at voltage, phase, and capacity the McPherson BPU has available.

Monthly Charges:

Energy Charge: \$0.0340 per net kWh, exclusive of any capacity charges

Maintenance Charge: See Maintenance Charge below

Energy Adder Adjustment: Energy Adder Adjustment multiplied by kWh usage

City Transfer Charge: City Transfer Charge multiplied by kWh usage

Maintenance Charge:

The actual cost of labor and equipment to maintain the City's street lighting system will be billed to the city.

The Maintenance Charge shall be derived dividing the preceding year's street light maintenance cost (FERC Acct. #585) by the yearly kWh consumption and rounding to the nearest mil/kWh.

For yearly budget purposes, the McPherson BPU will provide the City of McPherson information relative to the previous year's costs, and the projected costs for the next budget year.

Energy Adder Adjustment:

The above energy charge is based on net bus bar energy charges of \$0.02000 incurred by the McPherson BPU, exclusive of any capacity charges.

The above energy charge will increase or decrease in the amount that the cost of energy incurred by the McPherson BPU varies from a base of \$0.02000 per net kWh times a 1.03 line loss multiplier to the nearest \$0.00001 per net kWh.

City Transfer Charge:

All energy billed in connection with this rate schedule is subject to a City Transfer Charge, billed monthly as mils per net kWh to the nearest \$0.00001 per net kWh. The City Transfer Charge was enacted to recover funds for transfers made by the McPherson BPU to the City of McPherson as Payments in Lieu of Taxes.

The City Transfer Charge will be modified as necessary to provide a matching of the total mandated Transfer set forth by the Governing Body of the City of McPherson, Kansas.

Payment Information:

Bills are due and payable upon receipt; if not paid within twenty-six (26) days from billing date, the bill becomes delinquent. When a bill becomes delinquent, a late payment charge in an amount equal to two percent (2%) of the delinquent amount owed for utility service will be added to the customer's bill.

Notes:

1. Effective June 1, 2022, Electric Service Schedule SL-11 shall be replaced by SL-22. Customers billed from Schedule SL-11 before June 1, 2022, shall then be billed from Schedule SL-22 moving forward.
2. Effective January 1, 2011, electric service Schedule SL-84 shall be replaced by SL-11. Customers billed from Schedule SL-84 before January 1, 2011, shall then be billed from Schedule SL-11 moving forward.
