Pole and Conductor, if special setting is required \$11.00 each per month
Transformer setting, if special setting is required
Conductor (each span)
The above prices include all installation and maintenance, and energy if specified.

The Luminaire Rental Contract will be month-to-month basis. If contract is cancelled within two years, there will be an installation fee assessed of \$171.

The BPU will perform all maintenance during regular daytime working hours as soon as practical following notification by the customer. Limit two lights per service location with existing locations grandfathered until changes are made to the account. Installation will be on a BPU pole.

Lights can either be high pressure sodium or LED, BPU's discretion. A customer can change to an LED fixture for the cost of the fixture.
